The Town Clerk upon receipt of the returns from several precincts, forthwith canvassed the same and announced the final results at approximately 11:10 PM

At the Annual Town Election held Tuesday, April 29, 2025 Milton had the following number of Absentee Ballots.

Of the total Absentee ballots cast, fifty-two were cast in person by the voter in the Office of the Town Clerk. Four ballots were sent to UOCAVA voter and returned to the Office of the Town Clerk before 8:00 PM on April 29, 2025. The Absentee ballots voted in person were sent to the respective precinct to be processed on Election Day. The Warden put the ballots through the Ballot Box tabulator and they were counted with the ballots cast in person in the precinct. The UOCAVA ballots were hand counted after 8:00 PM in the Office of the Town Clerk and the results were added to the respective precinct total.

Of the total Early Vote By Mail Ballots mailed one hundred twenty-six were mailed and not returned before 8:00 PM on April 29, 2025.

The Early Vote by Mail Ballots received on or before April 24, 2025 were processed during advance processing in Town Hall, Blute Conference Room on April 25, 2025. The Election Officials put the ballots through a tabulator, the result of which were printed after 8:00 PM on Election Day. Early Vote Ballots received after April 24, 2025 were sent to the respective precinct to be processed on Election Day. The Warden put the ballots through the Ballot Box tabulator and they were counted with the ballots cast in person in the precinct. The ballot cast results from the advance processing for each precinct was added to the Election Day ballot cast results for a total ballot cast.
