# Background

---

Mass. General Laws strictly control administration of liquor licenses under chapter 138

Two types of licenses

- On-premises: restaurants (MGL c. 138, s. 12)
- Off-premises: package stores (MGL c. 138, s. 15)

Broadly, three categories of communities

- Subject to the Quota System
- Not subject to the Quota System
- “Dry” Towns
  - Technically, no authority to issue any liquor licenses without special legislative approval
  - Milton is in the “dry town” category for ***on-premises*** only
- Quota system sets the maximum the local licensing authority ***may*** issue



# Liquor License Systems

---

On-Premises Quota: One per 1,000 residents (or fraction thereof)

Off-Premises Quota: One per 5,000 residents (or fraction thereof)

Milton under quota system:

- On premises: maximum of 30 licenses
- Off-premises: maximum of 6 licenses



# Liquor License Approval Process

---

Communities with authorization to issue liquor licenses:

- Apply to the Local Licensing Authority (Select Board)
- After local approval, requires approval from the Alcoholic Beverages Control Commission (ABCC)
- All entities are subject to all other permitting/licensing procedures (zoning, in particular)

***In Milton, this process applies to off-premises (package stores) licenses.***



# Liquor License Approval Process

---

Communities like Milton that lack authorization to issue liquor licenses:

- Submit a request for a warrant article to the Select Board
- Town Meeting approval (usually two opportunities to go to Town Meeting each year)
- Approval from the Legislature
  - Home Rule petition must be filed by the Town's legislative delegation, be heard by a committee, be approved by both the House and Senate, and be signed into law by the Governor
- Then once the license is available, apply to the Select Board for a license
- After local approval, apply to the ABCC for approval
- All entities are subject to all other permitting/licensing procedures: Board of Health, zoning, etc.

***In Milton, this process applies to all requests for on-premises licenses (restaurants).***



# Milton Liquor Licenses

---

## Off Premises (Package Stores)

- Quotas:
  - 6 for All Alcohol Sales; 2 available
    - Central Liquor Mart, East Milton Wine and Spirits, The Fruit Center, and Craft and Cru
  - 6 for Wine and Malt Beverages only; 6 available

## On Premises

- Quotas: N/A

# Alternatives

---

1. Continue with current practice – await applicant, with a specific location
  - Warrant Article -> Town Meeting -> Home Rule Petition -> Select Board
2. Submit a home rule petition to grant Milton greater flexibility moving forward
  - Request special authorization to put the question back before voters to move into the quota system
  - Request approval for a specific number of new licenses
  - Request approval for a specific number of new licenses, limited to certain neighborhoods / zoning districts
